# 41<sup>ST</sup> ATHENS MARATHON. THE AUTHENTIC STAVROS NIARCHOS FOUNDATION – GROUP REGISTRATION TERMS AND CONDITIONS

The Stavros Niarchos Foundation (SNF) will submit a Group Registration for the 41st "ATHENS MARATHON. THE AUTHENTIC," specifically for the Marathon Race on November 10, 2024, the 10km Road Race OPAP on November 10, 2024, and the 5km Road Race *Stoiximan* NIGHT RUN on November 9, 2024 (hereinafter each referred to as the "Race"). The management of the SNF Group Registration will be carried out in collaboration with "Regeneration and Progress" (RandP). RandP is a Civil Non-Profit Organization which designs and implements, free of charge, a series of actions in the fields of Health, Sports and Education, with the exclusive financial support of the SNF. Among the main activities of RandP in the field of Sports is the organizational supervision of the night race *SNF Nostos Run: Running to the Future* and the first run of the year *SNF RUN: FIRST RUN*.

Participation Age Limit: A necessary requirement for participation in the Race through the SNF Group Registration is that participants must be at least 18 years old.

Registration Level: Registrations for the Marathon via the SNF Group Registration are submitted at the Full Registration Level, while registrations for the rest Races are submitted at the Advanced Registration Level. The provided email address will be used for the confirmation of the participation of the runners as well as for the provision of information regarding the collection of the Race bibs and kits and instructions for the participation in the Race.

### **Participation Solemn Declaration**

By submitting this Application, I declare that I participate in the Race (Marathon/ 10km Race/ 5km Race) at my own personal responsibility, having undergone the necessary medical examinations and cardiac assessment. I declare that I have read the detailed terms of participation in the Race, which are included in the text titled Terms & Conditions of Participation (click here) (the "Race Terms") and I accept them. I also declare that all information stated above is completely correct. I waive and release all rights and claims from damages I may have against organizers of the Race for any physical or other injury or damage of any kind, and I give permission for the free use of my name/ image by the Media, SEGAS and the sponsors of the Race for promotional purposes. Finally, I confirm that in no case I give the bib number assigned to me by the Organizing Committee of the Race to another person for the latter's participation in the Race. I also understand and accept that there may be a health risk associated with my participation in group activities such as the Athens Marathon. I am choosing to register and participate in this Race with full awareness and understanding of this risk and, in this framework, the Organizing Committee of the Race and SEGAS bear no responsibility in case of any potential damage to my health.

Finally, I acknowledge and unequivocally accept that neither the SNF nor RandP bear any responsibility for the organization and execution of the Race as well as for any injury, damage or other harm of any kind which I may suffer or for the loss or damage of my personal belongings. By participating, I waive and release all rights and claims against SNF and RandP.
